Definition of "Available to Promise":

Orders must have signed prints when necessary

Customers must provide the following information regarding COM: product information, manfacturer, and arrival date to Grand Rapids Chair Customer must supply sample panel at time of promising for custom finish

Definition of "Estimated Lead time":

All lead times subject to change. Published lead times are estimates based on working production days, receipt of complete information and order size. Note lead times can change daily depending on incoming order volume.

How to avoid impacting lead-time:

Ensure order information is complete – finish selections, order details, finish approvals and custom matches.

For orders with seating upholstery, laminate or COM's – lead-time is determined based on material availability & on-time receipt.

For critical and large orders – please work closely with your Account Manager to plan accordingly.
