HOW TO ORDER

All orders must be submitted in writing and are subject to acceptance by Grand Rapids Chair Company. Orders cannot be processed until they contain all information required for production. Once all information is received and the order is approved, it will be scheduled into production.

It is the customer's responsibility to check the accuracy of each and every order acknowledgment sent by the factory. We will, of course, make every effort to find inadvertent errors, but will execute the order as approved and cannot accept responsibility for errors made on the customer's part.

Please note that all orders will be acknowledged with estimated lead times. Lead time begins once the order, along with custom stain matches and custom engineering prints have been approved, and C.O.M. fabric is received.

NEW ACCOUNTS

To expedite the credit approval process, please fill out a credit application that can be furnished to you by calling the sales office at 616.774.0561 or by email at arcashreceipts@grandrapidschair.com. Allow thirty (30) days to process a credit application.

CREDIT CARDS

We accept Visa, Master Card, Discover, and American Express. Additional charges may apply.

MINIMUM ORDERS

For orders less than \$250.00 net, a setup/handling fee of \$50.00 will be charged.

CANCELLATIONS/CHANGES

All orders are considered firm. Any cancellation or change is subject to our approval, and will result in an order cancellation fee including all applicable costs plus a reasonable profit of 10%.

RETURNS

Merchandise cannot be returned for credit without an approved return material authorization. The nature of our customized products inhibits most return requests, but for those items that can be returned, a restocking fee of 15% will be assessed for all items.

MATCHING GOODS

In the event a customer would like to match a previous order to a new order, the customer must send a physical sample to their Account Manager. Due to continual engineering improvements and modifications, we cannot guarantee each good will be an exact match to their previous order. In the event that we cannot offer a matching good, a suitable alternative (comparable in design, style, and durability) will be offered to the customer. The information contained in this price list was correct at the time of publishing. Grand Rapids Chair Company reserves the right to make changes in design and construction or discontinue products without prior notification.

DELIVERY

Orders will be shipped with normal shipping times. Special requests will be honored if possible. Once production has begun, orders cannot be held for extended delivery. It is the customer's responsibility to accept and store the furniture if there is an installation delay. Grand Rapids Chair Company will not be responsible or liable to purchaser for damages whether incidental, consequential, or otherwise for failure to fill orders, delays in delivery, or any error in filling the order.

FREIGHT

Risk of loss shall pass to the seller upon delivery of goods to a carrier. Grand Rapids Chair Company is not responsible for damage or delays in transit. It is the customer's responsibility to inspect product upon delivery for possible freight damage. It is also the responsibility of the customer to file freight claims for any damaged goods. Claims should be filed with the common carrier immediately upon discovery of such damage. Visible freight damage should be noted on the freight bill prior to taking receipt of the orders. Concealed damage claims must be filed within 5 days of receipt of shipment. C.O.D. shipments are subject to the freight carrier's fees for C.O.D. shipments.

HOLDING ORDERS

Grand Rapids Chair is a manufacturing facility, with limited storage space. If the customer requests to change the originally scheduled ship date, the customer will be responsible for applicable storage fees for partially produced and fully finished goods. Grand Rapids Chair will hold an order at no charge for a maximum of 14 calendar days. Any order held more than 14 days after the original ship date will be subject to a charge of \$20 per pallet/day.

UPHOLSTERY INFORMATION

UPHOLSTERY

Prices are based on a solid color 54" wide upholstery. Any upholstery with 3" or greater repeat, length or width, which requires pattern matching, add 10% to overall list price. Thread color will be chosen by factory to match the upholstery as closely as possible, unless otherwise specified.

CUSTOMER'S OWN MATERIAL (C.O.M.) AND CUSTOMER'S OWN LEATHER (C.O.L.)

Please consult the factory prior to placing your C.O.M. or C.O.L. order. We may be able to supply materials at a lower cost due to our volume discounts with the textile mills. All C.O.M. materials should be sent in rolls only, folding can cause adverse and irreversible deformations to some materials, especially leather.

FABRIC APPROVAL PROCESS:

Fabrics for Harper and Full Hurdle must be tested and approved by Grand Rapids Chair prior to production to ensure it meets our high standards for quality. There is no charge for the fabric testing process. A sample swatch must be supplied with the order along with the name of the supplying textile company and a description of the material (pattern name, color and any accompanying numerical description). We cannot accept responsibility for costs incurred for replacement material if the mill sends the incorrect fabric.

All C.O.M. yardage requirements in this price lists are based on 54" wide roll. Yardage is approximate. Add 10% to the yardage requirements if striped or patterned materials are specified, if pattern requires matching, or if width of material is less than 54" wide. For striped, patterned or unique designs, directions on upholstery application must be provided. If no directions are stated on the order or in a subsequent "confirmed and acknowledged" document, we will upholster the product in what we deem to be the most appropriate manner. We assume no responsibility thereafter.

Grand Rapids Chair Company assumes no liability as to the flame retardant qualities of a C.O.M.

For orders with C.O.L., add 10% to the list price of C.O.M. in our price list. We also advise adding 25% to the yardage requirements if specifying leather. Irregularities in grain, natural marks or variations in color are to be expected and are normal characteristics of natural luxurious leather, making each piece unique.

Acknowledged ship dates are dependent upon the timely receipt of C.O.M. or C.O.L. Delays in receiving the material will result in the rescheduling of production. We maintain the right to refuse the use of any customer-supplied material or leather that is not suitable due to pattern, stretch, weight or workability.

All C.O.M. must be shipped prepaid and clearly marked with your company name and purchase order number.

WOODS

Wood is an organic material that undeniably adds warmth to any space. Each species of wood has a unique and naturally occurring pattern that can vary greatly. Due to the complex structure of wood, small knots, piths, pores, rings, etc. may appear and add decorative appeal.

WOOD COLOR & SPECIES

Each species of wood has an innate base color, ranging from white to pinkish, yellow to brown and this impacts the way that stains and paints appear when applied. We primarily work with Beech and Maple wood species for our chairs and table tops. Each of our standard wood stains have been color matched so that any standard color will appear the same in both species.


STANDARD WOOD FINISHES

Available on seating and solid maple tables.

Black-No Grain and White-No Grain finishes are only available on seating products.

Hickory, White Oak, Walnut and Mixed Solid Wood table tops are only available with a natural, clear coat finish.

An asterisk (*) implies the finish is available on TON products (Bentwood, Merano and Leaf). TON's Black finish will show grain.



WOOD STAIN COLOR MATCHING

There is a \$200 net charge to match any wood stain. A physical sample chip must be sent to the Grand Rapids Chair factory for matching. Digital or paper copies will not be accepted. There is no minimum order. If there are any additional glazing operations, please contact Grand Rapids Chair company to be quoted by customer service.







Ipe is a premium and incredibly dense hardwood, naturally resistant to rot and decay. Ipe is unfinished and will weather to a natural grey patina. The Ipe species ranges in color from lighter olive browns to darker chocolate tones. This natural color variation is what makes Ipe desirable. This natural variation will be inherent in a single table top. If consistency is preferred, HDPE provides consistent color and grain through the manufacturing process of extruded plastic.

STEEL & ALUMINUM

We hand-tailor, cope and braze all joints to add even more stability, exceeding strength and durability standards and customer expectations. Powder coating is a type of coating that is applied as a free-flowing, dry powder. The coating is applied electrostatically and is then cured under heat to allow it to flow and form a "skin." It is used to create a hard finish that is tougher than conventional paint.

NAILHEAD COBBLER SEAT

Nailhead trim is applied to a wood seat leaving an irregular wood perimeter around the upholstery material.

NAILHEAD WATERFALL COBBLER SEAT

Nailhead trim is applied to a wood seat leaving a wood perimeter on the back and two sides of the seat. The upholstery material wraps over the front of the seat completing the waterfall appearance.

NAILHEAD SURROUND BACK

Nailhead trim is applied to the outside edges of the upholstery material located on the back side of the chair.

NAILHEAD TRIM SURROUNDING FRONT LEGS ON PULLMAN SEAT

Nailhead trim is applied around the front and side edges of the front legs on Pullman style applications.

WELTING

Welting, often referred to as piping, is a fabric-covered cord positioned on the corners and edges of upholstered pieces that restricts contact with the sewn seams, acting as a buffer to abrasions as the furniture is used.

BOXED SEAT

A sewn upholstery cover is pulled over thicker foam to produce a built up seat. Typically 2" tall. Boxed seats are not available on nesting chairs.

WEBBED SEAT

Commercial grade webbing is installed over custom plywood panels. This option adds additional comfort and longevity to any seat.





1. THE AGREEMENT

All sales by GRAND RAPIDS CHAIR COMPANY or its affiliates (the "Seller") shall be governed by the following terms and conditions of sale. The agreement between Seller and Buyer with respect to the sale of Goods described in the Seller's quote (the "Goods") shall consist only of the terms appearing herein and in the Seller's quote or proposal and any attachments, exhibits and supplements (together, the "Contract") together with any terms mutually agreed to in writing hereafter by Seller and Buyer. These terms and conditions of sale prevail over any of Buyer's general terms and conditions of purchase regardless whether or when Buyer has submitted its purchase order or such terms. Buyer's issuance of a purchase order constitutes its acknowledgment that Seller's quote is the first document exchanged, containing the essential elements of, and therefore constitutes an offer. Seller objects to and shall not otherwise be bound by any additional or different terms, whether printed or otherwise, in Buyer's purchase order or in any other communication from Buyer to Seller. The Contract shall be for the benefit of Seller and Buyer and not for the benefit of any other person. The Contract and these terms comprise the entire agreement between the parties, and supersede all prior or contemporaneous understandings, agreements, negotiations, representations and warranties, and communications, both written and oral. No statements, recommendations, or assistance by either party has been relied upon by either party or shall constitute a waiver by either party of the provisions hereof. Notwithstanding anything herein to the contrary, if a written Contract signed by both parties is in existence covering the sale of the Goods covered hereby, the terms and conditions of said Contract shall prevail to the extent they are inconsistent with these terms.

2. NO IMPLIED ACCEPTANCE

Notwithstanding any contrary provision in Buyer's purchase order, no action by Seller such as delivery of Goods, the rendering of services or the commencement of work on Goods to be specially manufactured for Buyer, will be deemed an acceptance by Seller of any purchase order from Buyer with terms in addition to or different than those contained in this Contract.

3. TERMINATION OR MODIFICATION

In addition to any remedies that may be provided under these terms, Seller may terminate the Contract with immediate effect upon written notice to Buyer, if Buyer: (i) fails to pay any amount when due under the Contract; (ii) has not otherwise performed or complied with any of these terms, in whole or in part; or (iii) becomes insolvent,

files a petition for bankruptcy or commences or has commenced against it proceedings relating to bankruptcy, receivership, reorganization or assignment for the benefit of creditors. The Contract may be modified only upon Seller's written consent. If all or part of the Contract is terminated, in the absence of a written agreement with Seller to the contrary, Buyer shall pay a termination charge equal to expenses and costs incurred by Seller in the production of the Goods to the date such termination is accepted by Seller, including work in process, raw materials not usable by Seller for other purposes, and reimbursement for any commitments to third parties made in order to satisfy Buyer's requirements, plus a reasonable profit. In addition, any Goods completed on or prior to Seller's acceptance of such termination shall be accepted and paid for in full by Buyer.

4. TERMS OF PAYMENT

Payment terms are determined on an individual company basis. Payments shall be made to Seller at the address specified in the invoice. Pro rata payments shall become due as shipments are made. If any shipment is delayed by Seller at the request of Buyer, payment shall become due on the date when Seller is prepared to make shipment. Prices are F.O.B. Seller's shipping point unless otherwise stated in the Contract. Product orders for non-standard items, and orders that exceed normal credit limits require 50% down payments with the order. When any payment is not paid on or before its due date, Buyer agrees to pay a late charge on the sum outstanding, from the due date for receipt of payment to the actual date of receipt of payment, at a rate of one and one half percent (1.5%) per month on the unpaid balance. If a payment is not paid on or before its due date, Buyer agrees that Seller may also cease performance under any and all of Buyer's purchase orders whether or not related to the late payment. Whenever, in the judgment of Seller, the financial condition of the Buyer does not justify the continuation of production or shipment on the specified terms of payment, the Seller may require full or partial payment in advance. Buyer hereby grants to Seller a security interest in all tools, molds, and dies and other property of Buyer which come into the possession of Seller, as security for all sums owing from Buyer to Seller from time to time. Buyer hereby authorizes Seller to file such financing statements with respect to such property as Seller shall deem appropriate and Buyer shall take whatever other actions are requested by Seller to perfect and continue Seller's security interest in such property.

5. DELIVERY

Delivery dates are not guaranteed but are estimated on the basis of immediate receipt by Seller of all information to be furnished by Buyer, and all shipments are subject to Seller's

production schedule. Seller shall in good faith endeavor to meet estimated delivery dates. Seller shall not be responsible for claims for error in quantity, weight or number not made within ten (10) days after Buyer's receipt of Goods. Seller will not be liable for any delay in performance of this Contract or delivery of Goods when the delay is caused directly or indirectly by fire, flood, explosion, accident, riot, disease pandemics, acts of God, war, governmental interference, embargo, strikes or other labor difficulties, shortage of labor, fuel, power, materials or supplies, transportation delays, failure of tooling or the repair, maintenance or rehabilitation of the tooling, or any other cause or causes whatsoever beyond its control. In the event Seller is delayed in performance by Buyer or at Buyer's request, Buyer will be responsible for any resulting increase in cost, including handling, insurance and storage charges, and Seller may invoice Goods ready for shipment with payment to be made in accordance with the payment schedule as if the Goods had been shipped. In the event delay is caused by Buyer's failure to furnish information necessary for Seller's performance, Seller may extend the shipment date for a reasonable time in proportion to the period of Buyer's delay.

6. INSTALLMENT DELIVERIES AS SEPARATE SALES

Each installment of Goods to be delivered pursuant to this Contract is to be considered as a separate sale and Buyer shall be liable to pay the agreed price for each such installment without regard to any failure to deliver other installments, and Seller's breach or default in the delivery of any installment shall not give Buyer the right to refuse to receive any other installments.

7. TITLE AND RISK OF LOSS

Title and risk of loss passes to Buyer upon delivery of the Goods to a carrier. Buyer assumes all risk of loss of Goods upon such delivery by Seller to the carrier. Seller agrees to package the Goods, put them in the possession of a carrier, make appropriate arrangements for their transportation, and obtain and deliver documents necessary to enable Buyer to obtain possession of the Goods. Seller shall not be obligated to obtain insurance or to prepay transportation costs unless the Contract provides otherwise. Buyer agrees to pay all loading, unloading and other charges incidental to transportation. Seller will attempt to follow Buyer's shipping instructions but may make reasonable changes thereto. Whether or not Seller pays shipping charges, risk of loss shall pass to Buyer upon delivery of the Goods to a carrier. Breach of this Contract shall have no effect upon this provision controlling the risk of loss. Buyer hereby grants to Seller a lien on and security interest in and to all of the right, title and interest of Buyer in, to and under the Goods, wherever

located, and whether now existing or hereafter arising or acquired from time to time, and in all accessions thereto and replacements or modifications thereof, as well as all proceeds (including insurance proceeds) of the foregoing. The security interest granted under this provision constitutes a purchase money security interest under the Michigan Uniform Commercial Code. Buyer hereby authorizes Seller to file such financing statements with respect to such property as Seller shall deem appropriate and Buyer shall take whatever other actions are requested by Seller to perfect and continue Seller's security interest in such property.

8. LIMITED WARRANTIES

Seller's Limited Warranty, adopted February 1, 2019, is hereby incorporated herein by reference.

SELLER MAKES NO OTHER WARRANTIES OR REPRESENTATIONS, EXPRESS OR IMPLIED, BY OPERATION OF LAW OR OTHERWISE, INCLUDING WITHOUT LIMITATION ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ALL OF WHICH ARE HEREBY SPECIFICALLY DISCLAIMED. In particular, but without limiting the generality of the foregoing exclusion, (i) if the Goods are made according to buyer's specifications, Seller does not warrant adequacy of such specifications or that the Goods will perform in accordance with such specifications, (ii) if any goods furnished hereunder are made by any supplier other than Seller, Seller does not provide any warranty with respect to such Goods, (iii) Seller does not warrant that the Goods are in compliance with laws of any country, and (iv) if the Goods are modules or assemblies, Seller does not warrant design, design performance, durability or system integration of the modules, assemblies or any components thereof.

Seller's sole obligation under the warranties set forth in Seller's Limited Warranty will be limited to either, at Seller's option, replacing or repairing defective Goods or refunding the purchase price paid for such Goods previously paid by Buyer, and Buyer's exclusive remedy for breach of any of such warranties will be enforcement of such obligation of Seller. These warranties will not extend to ordinary wear and tear or Goods subjected to misuse, abuse, neglect, damage, improper transportation, improper storage, improper cleaning, accident or improper installation or maintenance or which have been altered or repaired by anyone other than Seller or its authorized representative. Seller shall not be liable on any claim for defective Goods, which is not made within thirty (30) days after discovery of defect.

9. REMEDIES AND LIMITATION OF LIABILITY

In the event Buyer claims Seller has breached any of its obligations under the Contract, whether of warranty or

otherwise, Seller may request the return of the Goods and tender to Buyer the purchase price previously paid by Buyer, and in such event, Seller shall have no further obligation under the Contract except to refund such purchase price upon redelivery of the Goods. No Goods may be returned without Seller's written request. If Seller requests the return of the Goods, the Goods will be returned by Buyer unless otherwise authorized in writing by Seller. Seller reserves the right to inspect any claimed defect, repair defective Goods or install replacement parts, and perform any adjustment incident to satisfactory operation of the Goods. In the event Buyer claims Seller has breached any of its obligations under the Contract, whether of warranty or otherwise, and Seller has not delivered any Goods to Buyer, Seller may tender to Buyer the purchase price previously paid by Buyer, and, in such event, Seller shall have no further obligation under the Contract except to refund such purchase price previously paid by Buyer. The remedies contained in this and the preceding paragraph shall constitute the sole recourse of Buyer against Seller for breach of any of Seller's obligations under the Contract, whether of warranty or otherwise. In no event shall Seller be liable for loss of time, inconvenience, commercial loss, incidental, consequential or special damages, including without limitation, lost revenues, profits or recall expenses, nor shall Seller's liability on any claim for damages arising out of or connected with the Contract or the manufacture, sale, delivery or use of the Goods exceed the purchase price of the Goods previously paid by Buyer to Seller. Any warranty rights which Seller may have relating to any Goods provided by other suppliers will be assigned to Buyer upon request. Seller shall not be liable for failure to perform its obligations under the Contract resulting directly or indirectly from circumstances beyond Seller's reasonable control.

10. INDEMNIFICATION

Buyer shall indemnify Seller against, and hold Seller harmless from, any and all claims and liabilities, including reasonable attorney's fees, arising out of, connected with, or resulting from the Goods, including but not limited to, the design, manufacturing, selection, delivery, possession, storage, use, operation or disposition of the Goods. Seller's entire liability for Goods is limited as set forth in paragraph 9 above.

11. PATENTS

Buyer shall indemnify Seller against liability, loss, damage or expense in any instance involving alleged violation of patent rights relating to Buyer's specifications and/or the Goods resulting from those specifications. Buyer shall bear the full burden for all liability, loss, damage or expense in any such instance. Such indemnification of Seller against all liability, loss, damage or expense pursuant to this provision shall

include, but is not limited to, litigation expenses, reasonable attorney's fees, and damages awarded under an adverse judgment or established by way of compromise settlement where both Buyer and Seller have notice of and consent to such compromise settlement.

12. CHANGES

Changes in the work to be performed under the Contract may be made only if Buyer submits written instructions for such changes and if Seller accepts those changes in writing. If any such approved changes in drawings, materials, quantities, dates of performance or design of the part, units, tools, or fixtures, in Seller's sole judgment, increase Seller's costs, Seller may condition approval of any such change on agreement by Buyer to a price increase to recoup such cost increase, plus a reasonable return.

13. CANCELLATION/RESCHEDULE OF PURCHASE ORDERS

- A. In the event of any cancellation of all or part of any purchase order by Buyer, Buyer agrees to pay Seller for all reasonable and allocable materials, material management, labor, overhead and general and administrative costs and expenses incurred as a result of any such cancellation, plus a reasonable profit hereby stipulated to be ten percent (10%) of such costs and expenses within thirty (30) days from the date of Seller's invoice setting forth such costs and expenses. By way of illustration and not limitation, Seller's costs incurred by reason of Buyer's cancellation may include the storage costs for the items to be purchased, and costs associated with relocating the production to an alternate source, as well as the costs of unreimbursed and/or unamortized research and development costs, capital equipment, and other property and supplies of Seller needed to produce and which are unique to the Goods.
- B. In the event of such cancellation and upon receipt of payment as described above, all completed Goods, assemblies in process, components and any tooling, and equipment owned by Buyer and furnished to Seller under this Contract shall be returned to Buyer in accordance with instructions specified by Buyer.
- C. In the event of any cancellation, inventory carrying charges will be assessed at a rate of \$20 per pallet/day on the inventory stored until the relevant inventory is disposed of and paid for by Buyer.
- D. In the event of any reschedule of delivery of Goods by Buyer the Buyer will be responsible for applicable storage fees for partially produced and fully finished goods. Grand Rapids Chair will hold an order at no

charge for a maximum of 14 calendar days. Any order held more than 14 days after the original ship date will be subject to a charge of \$20 per pallet/day.

14. DISCLOSURE AND USE OF INFORMATION

All non-public, confidential or proprietary information of Seller, including but not limited to specifications, samples, patterns, designs, plans, drawings, documents, data, business operations, customer lists, pricing, discounts or rebates, disclosed by Seller to Buyer, whether disclosed orally or disclosed or accessed in written, electronic or other form or media, and whether or not marked, designated or otherwise identified as "confidential" in connection with the Contract is confidential and proprietary, solely for the use of performing the Contract and may not be disclosed or copied unless authorized in advance by Seller in writing. Upon Seller's request, Buyer shall promptly return all documents and other materials received from Seller. Seller shall be entitled to injunctive relief for any violation of this Section. Any information owned or developed by Seller, including but not limited to, patents, trademarks, copyrights, know-how and proprietary information, and used for the supply of Goods under this Contract shall remain the sole and exclusive property of Seller. Except as authorized in writing by and on terms acceptable to Seller, Buyer shall have no right to disclose any technical information to any third party or to have any third party make any Goods that use the technical information owned by Seller.

15. MATERIAL PRICE INCREASES

Seller's price quotation shall be subject to pricing of raw materials or other commodities used in the manufacture of Goods as described to Buyer. If any such price shall increase by more than five percent (5%) during the term of the Contract, then the quoted price shall be adjusted on the last day of each month thereafter to reflect the full amount of any such price increase.

16. GOVERNING LAW AND FORUM

The formation and performance of the Contract shall be governed by the Uniform Commercial Code, as adopted in the state of Michigan. Any action for breach of the Contract, including any breach of warranty, must be commenced within one (1) year after the cause of action has accrued. This Contract shall not be subject to or governed by the United Nations Convention on Contracts for the International Sale of Goods. Any legal or equitable actions arising out of or relating to this Contract or any other Contract between the parties, shall be brought only in the United States District Court for the Western District of Michigan, or in the district or circuit

courts of Kent County, Michigan. Seller and Buyer agree that such court shall have *in personam* jurisdiction over them.

17. TAXES

Unless the Contract provides otherwise, sales, use, occupation, excise and other taxes upon the production, sale or use of the Goods are not included in the price and such taxes or any costs in connection therewith, wherever levied and whether imposed before or after payment of invoice, shall be paid by Buyer.

18. MINIMUM PURCHASE REQUIREMENTS

Buyer hereby acknowledges and agrees that the prices set forth in this Contract are contingent upon Buyer's agreement to purchase the total quantities set forth in the Buyer's request for quote/proposal. If Buyer fails to purchase at least ninety percent (90%) of the quantities of Goods contained in its request for quote/proposal, Buyer agrees that the pricing on the Goods delivered to Buyer shall be adjusted retroactively to reflect the impact of lower volume on material pricing, labor efficiencies and other cost and expenses of Seller. Buyer hereby agrees to pay Seller such additional sums within thirty (30) days of the date of Seller's invoice for payment.

19. ASSIGNMENT AND DELEGATION

No right or interest in this Contract shall be delegated or assigned by Buyer without the prior written permission of Seller. Any attempt at assignment or delegation shall be void unless made in conformity with this paragraph. Buyer represents and warrants to Seller that any assignee of Buyer's rights under this Contract shall be in a financial condition and otherwise able to perform all of Buyer's obligations here under. No assignment of this Contract shall relieve Buyer of its liability under this Contract.

20. COMPLIANCE WITH LAW

Buyer shall comply with all applicable laws, regulations and ordinances. Buyer shall maintain in effect all the licenses, permissions, authorizations, consents and permits that it needs to carry out its obligations under the Contract.

21. WAIVER

No waiver by Seller of any of the provisions of the Contract is effective unless explicitly set forth in writing and signed by Seller. No failure to exercise, or delay in exercising, any right, remedy, power or privilege arising from the Contract operates, or may be construed, as a waiver thereof. No single or partial exercise of any right, remedy, power or privilege hereunder precludes any other or further exercise thereof or the exercise of any other right, remedy, power or privilege.

22. FORCE MAJEURE

The Seller shall not be liable or responsible to Buyer, nor be deemed to have defaulted or breached the Contract, for any failure or delay in fulfilling or performing any term of the Contract when and to the extent such failure or delay is caused by or results from acts or circumstances beyond the reasonable control of Seller including, without limitation, acts of God, flood, fire, earthquake, explosion, governmental actions, war, invasion or hostilities (whether war is declared or not), terrorist threats or acts, riot, or other civil unrest, national emergency, revolution, insurrection, epidemic, lockouts, strikes or other labor disputes (whether or not relating to either party's workforce), or restraints or delays affecting carriers or inability or delay in obtaining supplies of adequate or suitable materials, materials or telecommunication breakdown or power outage.

23. RELATIONSHIP OF THE PARTIES

The relationship between the parties is that of independent contractors. Nothing contained in the Contract shall be construed as creating any agency, partnership, joint venture or other form of joint enterprise, employment or fiduciary relationship between the parties, and neither party shall have authority to contract for or bind the other party in any manner whatsoever.

24. NO THIRD-PARTY BENEFICIARIES

The Contract is for the sole benefit of the parties hereto and their respective successors and permitted assigns and nothing herein, express or implied, is intended to or shall confer upon any other person or entity any legal or equitable right, benefit or remedy of any nature whatsoever under or by reason of these Terms.

25. SEVERABILITY

If any term or provision of the Contract is invalid, illegal or unenforceable in any jurisdiction, such invalidity, illegality or unenforceability shall not affect any other term or provision of the Contract or invalidate or render unenforceable such term or provision in any other jurisdiction.

26. SURVIVAL

Provisions of these terms which by their nature should apply beyond their terms will remain in force after any termination or expiration of the Contract.

- Solid Wood: 1 year free from finish defects and workmanship failures; 10 years structural integrity in the frame.
- Laminate: Subject to the warranty of the laminate supplier, if any, and to the extent assignable.
- Solid Surface: Subject to the warranty of the solid surface supplier, if any, and to the extent assignable.

OUTDOOR TABLE TOPS

- Metal: 1 year free from finish defects and workmanship failures; 3 years structural integrity in the frame.
- Werzalit: 1 year free from finish defects and workmanship failures; 3 years structural integrity.

- 1 year free from finish defects and workmanship failures; 3 years structural integrity in the frame.

OUTDOOR SEATING

- 1 year free from finish defects and workmanship failures; 3 years structural integrity in the frame.

UPHOLSTERY

- Customer's Own Material & Leather and Seller's Graded-in fabrics are subject to the warranty of the supplier, if any, and to the extent assignable.

COMPONENT PARTS & FITTINGS

- The following component parts not manufactured by Seller are covered under a 1 year warranty within normal use scenarios: screws, glides, casters, foot rests, plastic brackets, table hooks, Velcro, grommets, wire management, washers, stacking bumpers, purse shelf, foot rings, table-flip mechanisms, table-fold mechanisms, and table connectors.
- All other component parts not manufactured or supplied by Seller come without warranty.
- By way of example and not in limitation of the foregoing, electrical components are not covered under the Seller's warranty and are subject to the warranty of the electrical components supplier, if any and to the extent assignable.

SPECIALS/CUSTOM PRODUCTS

- If the goods are made according to the Buyer's specifications, Seller does not warrant adequacy of such specifications or that the goods will perform in accordance with such specifications.

III. PROVISIONS APPLICABLE TO ALL SELLER PRODUCTS AND SERVICES

WHAT IS NOT COVERED BY WARRANTY

- I. No warranty is made as to the selection, aesthetics, colorfastness, wear, or aging capability of fabrics, fabric treatments, finishes, or filling materials, including, but not limited to fillers such as foam/poly, cotton, and cardboard. Rusting of cast iron is not covered by warranty.
- II. Wood has a unique and naturally occurring pattern that can vary greatly. Due to the complex structure of wood, small knots, piths, pores, rings, etc. may appear and add decorative appeal. Variation in finish color due to organic variation in wood is not covered and is expected to occur.
- III. Flipping a chair on the top of a table will cause damage to the structural integrity and finish of both products and will accelerate the wear and tear of the table top finish and seat finish. Damage caused by flipping chairs on tables is not covered under the warranty.
- IV. "Stacking" items are susceptible to more wear and tear due to constant stacking; the warranty does not cover seat finish wear due to stacking or scratches/chips in powder coat finish where the legs meet during the stacking process.
- V. Solid wood and laminate table tops must be stored and used in indoor environments with relative humidity in the range of 35% to 50%. Exposure to relative humidity outside this range will cause the product to warp, check, or crack, resulting in loss of warranty coverage.
- VI. Charges for shipping, handling, installation, or disposal of defective units and/or replacement units unless approved in writing by Seller.
- VII. These warranties will not extend to ordinary wear and tear or goods subjected to misuse, abuse, neglect, damage, improper transportation, improper storage, improper cleaning, accident or improper installation or maintenance or which have been altered or repaired by anyone other than Seller or its authorized representative.

In the event that a product or component is no longer available for any reasons or we have discontinued a particular material, part, or product, then the Seller will have no liability due to the inability to replace any unavailable part.
